WHEREAS, the Annual Budget for Washington Township FD No. 1 (Gloucester) (the 'Fire District') for the fiscal year beginning January 1, 2024 and ending December 31, 2024 has been presented before the Board of Commissioners of the Fire District at its open public meeting of December 7, 2023; and

WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et seq.); and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$9,523,768.00 which includes an amount to be raised by taxation of \$8,606,614.00 and Total Appropriations of \$9,523,768.00; and

WHEREAS, the amount to be raised by taxation to support the district budget shall be the amount to be certified to the assessor of the municipality to be assessed against the taxable property in the district, pursuant to N.J.S.A. 40A:14-79. Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on December 7, 2023 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2024 and ending December 31, 2024 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the Fire District's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

Slight tax increase are due to the increased number of retired personnel cost of healthcare, insurance, hiring of personnel, contractual salary increases and other items due to the continued higher rate of inflation. LOSAP funding was increased due to the latest LOSAP financial review. Debt service has increased due to a new Capital Lease that is included in the 2024 budget.

3. **Explain any variances over +/-10% for each line item.** Attach in FAST any supporting documentation that will help to explain the reason for the increase/decrease in the budgeted line item.

Membership/Dues/Software License decrease by 22% due to a purchase of software licenses. Advertising increase by 16% due to an increase in publication costs. Fire Prevention Education in Other Appropriations offset with revenue decreased by 100% to balance this category to revenues. Revenues on investment accounts increased by 733% due to better rates on interest accounts. CPA Center Reimbursement increase by 72% due to the increased use of the CPA Center for plays, concerts and other events. Penalty and Fines increase by 120% due to comparison of 2023 budget to 2023 revenues in their line item. Other Revenues decreased by 12.9% due to comparison of 2023 budget to 2023 revenues. Other Assets-Non-Bondable have increased by 30% due to the required upgrades to vehicle computers to conform with county requirements. Fringe Benefits for Appropriations offset with revenues increased by 36% to insure that the Revenue and Appropriations Offset by Revenues match exactly as promulgated in previous years by DLGS. The LOSAP contribution increase is due to the recommendation valuation update. Please note that the Washington Township Fire District LOSAP is a defined benefit program. Items on Page F-3 (Detail 2) are Other non-bondable assets. The total increase is explained above but individually as follows: Security Camera Replacement (-100%) complete. Fire Fighting Equipment increased by 16.7% due to increased costs. Appliances (-100%) project complete. Thermal Imaging Camera (-100%) project complete. Computers & Accessories Upgrade increased by 732.5% due to need to purchase new mobile computers for fire apparatus to be compatible with new Pro-Phoenix software the Gloucester County will be using. Furniture and Fixtures increased by 100% to replace old outdated items of furniture at various stations. Communications Equipment increased by 100% due to need to purchase additional paging devices. Maintenance Shop Equipment increase by 100% due to purchase of a new salt spreader for snow/ice emergencies and Air Conditioning machine for vehicles that is capable of using new 1234YF refrigerant. Inspira anticipated revenue reduction is due to reduced repair needed because of fleet replacement. Inspira has also opened their own repair facility reducing the amount of work required by the Fire District.

If Unrestricted Fund Balance is reduced by more than 10%, explain the projected impact on the following year's budget.

The amount to be raised by taxation will increase by 4.4% in 2024 budget. The tax rate will increase from \$0.177 to \$0.183 per \$100 of valuation. This will mean that a home with a valuation of \$200,000 will pay \$366.00 per year for the Fire District an increase of \$16.00 per year from the 2023 adopted budget. Unrestricted fund balance was decrease from \$615,000 in 2023 to \$550,000 for 2024. This will keep the 2024 budget within the 2% tax levy cap.
